

Accessibility Checklist for Exercise Facilities

This resource is intended to provide a quick guide for assessing accessibility and usability for people with MS. For further information, consult the **Americans with Disabilities Act** website at <u>www.ada.gov</u> or an experienced architect.

Entrances & Doors

- \Box Is there an approach path without stairs? (Y/N)
- \Box Is the path stable, firm and slip-resistant? (Y/N)
- \Box Is the path at least 36 inches wide? **(Y/N)**
- \Box Is the main entrance free of barriers/steps, etc.? (Y/N)
- \Box If there are barriers, is there another accommodation such as a ramp, lift, or alternative accessibly entrance? (Y/N)
- \Box Are there accessible entrance doors? **(Y/N)**
 - Clear opening of at least 32 inches wide
 - Door handles are no higher than 48 inches
 - Can be operated with a closed first
 - Interior doors do not require more than 5 pounds of force to operate (local fire regulations may pre-empt this)
 - Doors with closers take at least 3 seconds to close
 - Doors have a level threshold (less than 1/4 inch high) or beveled (no more than 1/2 inch high)
 - Doormats are no higher than 1/2 inch and are secured to the floor at all edges

Ramps

- □ Do ramps have slopes no greater than 1:12 (which means that for every 1 inch of height or rise, there are 12 inches (1foot) of ramp "length" or "run"? **(Y/N)**
- \Box Do ramps longer than 6 feet have railings on both sides? (Y/N)
- \Box Do ramps have a non-slip surface? (Y/N)

Lockers and Showers

- □ Do entrances and doors to locker rooms have a clear opening of at least 32 inches? (Y/N)
- \Box Do entrances and doors to locker rooms provide necessary clearances for guests with restricted mobility? **(Y/N)**
- \Box Do locker rooms include accessible lavatories, urinals, water closets, showers, dressing booth, and lockers as well as provide an accessible route from the entrance to these fixtures? (Y/N)

Swimming Pool

- \Box Is at least one pool entry/exit available for people with restricted mobility? **(Y/N)**
- \Box Do steps into swimming pools have slip-resistant treads or finish? (Y/N)
- □ Are there handrails at steps to provide support to the user on both the right and left side? **(Y/N)**
- \Box Is the pool temperature between 82-85 degrees Fahrenheit? (Y/N)
- \Box Is there a lift available? **(Y/N)**

Miscellaneous

- □ Are staff members trained and available to assist with mobility needs, if necessary? (Y/N)
- □ Are there accessible fire exists/emergency procedures for people with limited mobility? **(Y/N)**
- \Box If so, where are they located?
